Legislative Paper - Assembly Bill 882

Assembly Bill [AB] 882 School Nursing and Student Services Task Force is a measure

introduced February 16, 2017 by state Assemblymember Dr. Joaquin Arambula. AB882 is an

act to add an article to Section 49420 of the to Education Code, relating to pupil health care

services (California Legislative Information [CLI], 2017). According to the Legislative

Counsel's Digest (2017), AB882 as amended by Dr. Arambula legislates the following:

- Existing law requires the governing board of a school district to give diligent care to the health and physical development of pupils, and authorizes the governing board of a school district to employ properly certified persons for that work.
- Existing law authorizes a school nurse, subject to the approval by the governing board of the school district, to perform various pupil health care services
- This bill would establish the School Nursing and Pupil Health Care Services Task Force consisting of 18 members, appointed as specified in the bill
- The bill would specify that the main task of the task force shall be to
 - o Identify model school health care services programs and practices that directly serve pupils
 - Preserve pupils' ability to learn
 - Fulfill existing state requirements and policies regarding pupil's health
 - Contain health care costs through preventive programs and education
 - o Which can be used by county offices of education and school districts to provide support and technical assistance to schools within each jurisdiction
 - o In order to improve the safety and quality of health care services to pupils
- The bill would require the task force to perform specified actions, including among others
 - o Examining health care funding sources
 - o Investigating the billing of pupil's health insurance
 - o Recommending standards of school nursing practices
- The bill will require the State Department of Education to convene one or more meetings of the task force to complete these requirements and to report the results to the Governor and the Legislative on or before January 1, 2019.

initiated grassroots campaigning through the CSNO membership to promote passage of the

statute. CSNO made the following comments regarding the recent action of the Education

Committee:

Our CSNO president and president elect also testified before the committee as well as meeting with their legislators to advocate for passage when the bill reaches the Assembly floor. CSNO further stated, "A good day for school nurses and the students, families and communities they serve. Thank you all for the support and advocacy to bet AB882 passed out of the 2 policy committees"

I am writing in support of AB882 Arambula bill Pupil Health Care Services: School Nursing and Pupil Health Care Services Task Force submitted to the Committee on Appropriations May 5, 2017.

If passed, AB882 Arambula will identify model school health care services, programs, and practices that directly service pupils and offer recommendations to county office of education and school districts resulting in improved safety and quality of health care services to pupils within our state.

California has over 10,000 schools with an enrollment of 6.2 million students. Currently there is a school nurse to student ratio of 1:3,048. I am one of these school nurses and carry a caseload of over 3,000 students in Central California. The numerous chronic and acute illnesses and specialized health care needs my students bring to school need addressing. Children cannot reach their full education potential unless they are healthy and ready to learn. School nurses are uniquely qualified to the primary care of pupils and work to reduce absenteeism through effective health interventions for acute and chronic illnesses as well as preventative programs and education, which ultimately reduces health care costs. However, there is no funding or line item in the state budget or local LEA budgets to address the shortages of health care personnel necessary adequately meet my students' health care needs. This bill will provide recommendations to address these needs.

Thank you for taking the time to review my support on this issue. I would appreciate your supportive vote in the appropriations committee for SB882 Arambula.
