COVID-19 Related Provisions

Course Description:

Current and proposed legislation in parent-child relationships, adoption, and guardianship, education of the minor, marriage contract, child labor, juvenile delinquency, and child welfare programs. This course presents an overview of traditional legal policies concerning minors in the home, in the school and in the juvenile justice system, with an emphasis on applying traditional guidelines to contemporary issues.

COURSE SPECIFICS OBJECTIVES: (CTC 2, 3, 6, 7, 18 INTRODUCE)

- 1. The student will identify the significant aspects of the American legal system relating to minors. (CTC 6, 18)
- 2. The student will discuss the autonomies and protections provided to minors regarding property ownership, marriage, employment, health and medical treatment, and civil litigation generally. (CTC 6)
- 3. The student will describe the nature and extent of the rights conferred on juveniles by the U.S. Constitution. (CTC 6, 18)
- 4. The student will explain the development of the juvenile justice system both before and after In re Gault. (CTC 6)
- The student will summarize the legal aspects of the home-school relationship, including the responsibilities and obligations of children, of parents and of school personnel in matters of attendance, curriculum, discipline and supervision. (CTC 2, 6, 7, 18)
- 6. The students will describe the laws that apply in determining custody and control of minors in various legal proceedings. (CTC 6)

- The student will describe the processes and limitations for state intervention to ensure adequate parenting--including child abuse reporting laws, protective placements for children, dependency actions, and terminating parental rights. (CTC 6)
- 8. The students will analyze contemporary problems applying the general and specific legal principles that apply to children in the home, in school and in society. (CTC 6, 18)
- 9. The student will identify multicultural issues and concerns that relate to specific applications of law relating to minors. (CTC 3, 6)
- 10. The student will comprehend the implications and legal applications of due process; the student will describe the dynamics of the laws pertaining to reduce the incidences of sexual harassment in school. (CTC 6)

Course Requirements/Assignments: (See Course Schedule for Due Dates)

Class Attendance & Participation – Weekly Discussion Boards – 15 (20 points each = 300 points total) (CTC 2, 3, 6, 7, 18 Introduce)

Class participation is necessary to pass the course. If you know that you are going to be late or absent, please let the instructor know in advance. Students are expected to read all assigned reading materials and actively participate in class discussions and discussion boards. It is expected that students will come to class prepared to discuss assigned readings and engage with the instructor, fellow colleagues, and guest speakers in pertinent class activities. Grades may be lowered due to lack of participation and incomplete discussion board assignments.

Quizzes – 3 (50 points each = 150 points total) (CTC 2, 3, 6, 7, 18 Introduce)

There will be three (3) quizzes. Quizzes consist of 25 questions (2 pts each) and possible extra credits. The quizzes are available online via Canvas. There are no make-up quizzes unless prior arrangements have been made and approved by the instructor. Should you need special accommodations, please meet with me to discuss your needs.

Reflection Papers – 3 (50 points each = 150 points total) – Online Submission (CTC 2, 3, 6, 7, 18 Introduce)

Students will be expected to read all the materials assigned in this course. Students will choose three (3) chapters of their choice and write a 1-2 page (not including title page and reference page) reflection on each of the chosen chapters. The reflection paper should include feelings, thoughts, concerns, ideas, personal and professional experiences, questions, etc. The paper should be in APA format.

Final Research Paper (100 points) – Online Submission (CTC 2, 3, 6, 7, 18 Introduce)

Each student will turn in a final research paper that focuses on a topic of interest that is relevant to this course. Optional: Students may extend research from one of the topics that they have written about in their reflection papers. The topic can relate to the student's particular degree, ethnic/family background, personal and professional experiences, and/or credential objective. This paper should be at least 5 pages in length (not including title page and reference page), a minimum of 3 peer-reviewed articles and/or published books, and in APA format.
