- _____ Clinical practice hours for credit may be earned only through student teaching or while teaching under a university internship credential in public schools, pre-approved charter schools or pre-approved non-public schools, within the university's service area. - _____ Fresno State does not accept field placements or internships in private, charter, or online schools not affiliated with an approved public school district outside the 45-mile radius from Fresno State.
- _____ Fieldwork placements, including placements as teacher of record, are at the discretion of the program, not the candidate nor the employer." (CCTC Intern Specific Preconditions, May 2011, page 6).
- _____ Teachers of record working under a temporary permit including STSPs, PIPs, substitute including long term permits, emergency permits or other permits must move to a university internship credential to receive credit for fieldwork experience while employed as the teacher of record.
- _____ A salary deduction of \$1,600 per semester will occur through district payroll.
